# A Condition on a Certain Variety of Groups. 

Alireza Abdollahi (*) - Bijan Taeri (*)

Abstract - Let $\alpha_{1}, \ldots, \alpha_{n}$ be nonzero integers whose greatest common divisor is $d$. We prove that an infinite group $G$ is of finite exponent dividing $d$ if and only if for every $n$ infinite subsets $X_{1}, \ldots, X_{n}$ of $G$ there exist $x_{1} \in X_{1}, \ldots, x_{n} \in X_{n}$ such that $x_{1}^{\alpha_{1}} \ldots x_{n}^{\alpha_{n}}=1$.

## 1. Introduction.

Let $\mathcal{O}$ be a variety of groups defined by the law $v\left(x_{1}, \ldots, x_{n}\right)=1$. We say that $G$ is a $\mathfrak{V}^{\#}$-group if for every $n$ infinite subsets $X_{1}, \ldots, X_{n}$ of $G$ there exist $x_{1} \in X_{1}, \ldots, x_{n} \in X_{n}$ such that $v\left(x_{1}, \ldots, x_{n}\right)=1$.

In [4] P.S. Kim, A.H. Rhemtulla and H. Smith posed the following question: for which variety $\mathcal{V}$, is every infinite $\mathfrak{V}^{\#}$-group a $\mathfrak{V}$-group?

There exist positive answers for the variety $\mathcal{G}$ of abelian groups defined by the law $[x, y]=1$ (see [7]), the variety $\mathcal{Q}_{2}$ defined by the law $[x, y]^{2}=1$ (see [5]), the varieties $\delta_{2}$ and $\delta_{3}$ of 2-Engel and 3-Engel groups defined by the laws $[x, y, y]=1$ and $[x, y, y, y]=1$, respectively (see [10] and [11]), the variety $\mathscr{B}_{n}$ of groups of exponent dividing $n$, defined by the law $x^{n}=1$ (see [6]), the variety $\mathcal{N}_{k}$ of nilpotent groups of nilpotency class at most $k$, defined by the law [ $\left.x_{1}, \ldots, x_{k+1}\right]=1$ (see [6]), the variety $\mathcal{G}_{3}$ of 3 -abelian groups defined by the law $(x y)^{3} y^{-3} x^{-3}=1$

(see [1]) and, the variety generated by the law $x_{1} \ldots x_{n}=1$ (see [3]).
Now let $\mathcal{V}$ and $\mathcal{W}$ be varieties of groups defined by different laws $v\left(x_{1}, \ldots, x_{n}\right)=1$ and $w\left(y_{1}, \ldots, y_{m}\right)=1$, respectively. C. Delizia in [2] posed the question of whether $\mathfrak{V}^{\#}=\mathfrak{W}^{\#}$ when $\mathfrak{V}=\mathfrak{W}$, and for $k>1$, he investigated the question for the varieties $\mathfrak{V}=\mathcal{V}_{k}$ (the variety defined by the law $\left[x_{1}, \ldots, x_{k}, x_{1}\right]=1$ ) and $\mathfrak{W}=\mathcal{N}_{k}$.

For nonzero integers $\alpha_{1}, \ldots, \alpha_{n}$ with the greatest common divisor $d$, we have considered the question for the varieties $\vartheta \mathcal{~ d e f i n e d ~ b y ~ t h e ~ l a w ~}$ $x_{1}^{\alpha_{1}} \ldots x_{n}^{\alpha_{n}}=1$ and $\mathscr{B}_{d}$; proving

Theorem. $\mathcal{V}^{\#}=\mathfrak{B}_{d}^{\#}$.

## 2. Proofs.

Lemma 1. Let $\mathfrak{V}$ be the variety defined by the law $w\left(x_{1}, \ldots, x_{n}\right)=$ $=1$. If $G$ is an infinite $F C$-group in $\mathfrak{V}^{*}$, then $\left.G \in\right\urcorner$.

Proof. Let $\quad g_{1}, \ldots, g_{n} \in G$, then $\left|G: \bigcap_{i=1}^{n} C_{G}\left(g_{i}\right)\right| \leqslant \prod_{i=1}^{n}\left|G: C_{G}\left(g_{i}\right)\right|<$ ${ }_{n}^{<} \infty$. Thus $\bigcap_{i=1}^{n} C_{G}\left(g_{i}\right)$ is infinite. Let $A$ be an infinite abelian subgroup of $\bigcap_{i=1} C_{G}\left(g_{i}\right)$. Then $A \in \mathcal{V}$ by Lemma 3 of [3]. Now consider the infinite sets ${ }_{g_{1}}^{i=1} A, \ldots, g_{n} A$. By the property $\mathbb{V}^{*}$ there exist $a_{1}, \ldots, a_{n} \in A$, such that $w\left(g_{1} a_{1}, \ldots, g_{n} a_{n}\right)=1$. So

$$
1=w\left(g_{1}, \ldots, g_{n}\right) w\left(a_{1}, \ldots, a_{n}\right)=w\left(g_{1}, \ldots, g_{n}\right)=1
$$

and $G \in \mathcal{V}$.
From now on, for nonzero constant integers $\alpha_{1}, \ldots, \alpha_{n}$ and any nonzero integer $\alpha$ we denote the varieties defined by the laws $w=$ $=x_{1}^{\alpha_{1}} \ldots x_{n}^{\alpha_{n}}$ and $w=x^{a}$, respectively, by $\mathcal{V}$ and $\mathscr{B}_{a}$. Also we denote the greatest common divisor of $\alpha_{1}, \ldots, \alpha_{n}$ by $d$.

Lemma 2. Let $G \in \mathfrak{V}^{\#}$ be an infinite group. If the set $T=\{g \in$ $\left.\in G \mid g^{d}=1\right\}$ is infinite, then $G \in \mathcal{Y}$. In particular an infinite group in $)^{\#} \backslash \vartheta$ can not have an infinite subgroup in $\vartheta$.

Proof. Let $X$ be an infinite subset of $G$. Let $1 \leqslant j \leqslant n$ be fixed. By considering the infinite subsets $X_{i}=T, i=1, \ldots, j-1$, $j+1, \ldots, n$ and $X_{j}=X$, and using the property $\mathfrak{V}^{*}$, we find the elements $g_{i} \in T, \quad i=1, \ldots, j-1, j+1, \ldots, n$ and $x \in X$ such that
$g_{1}^{\alpha_{1}} \ldots g_{j-1}^{\alpha_{2}}{ }_{1}^{1} x^{\alpha_{\jmath}} g_{j+1}^{\alpha_{2}+1} \ldots g_{n}^{\alpha_{n}}=1$. But $g_{i}^{\alpha_{2}}=1$, so we have $x^{\alpha_{\jmath}}=1$. Thus $G \in$ $\in \mathscr{B}_{\alpha_{j}}^{\#}$, for all $j=1, \ldots, n$. Since $\mathscr{B}_{\alpha_{j}}^{\#}=\mathscr{B}_{\alpha_{j}} \cup \mathscr{F}$, we have $G \in \mathscr{B}_{\alpha_{j}}$, for all $j=$ $=1, \ldots, n$. So $G \in \mathcal{V}$, as required.

We define the class $\mathcal{V}(\infty)$ including all groups $G$ in which any infinite subset $X$ contains distinct elements $x_{1}, \ldots, x_{n}$ such that $x_{1}^{\alpha_{1}} \ldots x_{n}^{\alpha_{n}}=1$. Also, if $k \geqslant n$ is an integer, we define the class $\mathfrak{V}(k)$ including all groups $G$ in which any subset $X$ with $|X|=k$, contains distinct elements $x_{1}, \ldots, x_{n} \in X$ such that $x_{1}^{\alpha_{1}} \ldots x_{n}^{\alpha_{n}}=1$. It is clear that, $\mathcal{V}(k) \subseteq \mathcal{V}(\infty)$ and $\mathfrak{V}^{\#} \subseteq \mathfrak{V}(\infty)$.

Lemma 3. Let $G \in \mathfrak{Y}(\infty)$ be an infinite group. Then $\left|H: C_{H}\left(g^{d}\right)\right|$ is finite, for any $g \in G$, and any infinite subgroup $H$ of $G$.

Proof. Let $H$ be an infinite subgroup of $G$ and suppose, for a contradiction, that there is an element $g \in G$, such that $\left|H: C_{H}\left(g^{d}\right)\right|$ is infinite. Let $T$ be a right transversal to $C_{H}\left(g^{d}\right)$ in $H$. List the elements of $T$ as $t_{1}, t_{2}, \ldots$ under some well ordering $\leqslant$, so that $t_{i}<t_{j}$ if $i<j$.

Consider the set $T^{(n)}$ of all $n$-element subsets of $T$. For each $t \in T^{(n)}$, list the elements $t_{i_{1}}, \ldots, t_{i_{n}}$ of $t$ in ascending order given by $\leqslant$, and write $\hat{t}=\left(t_{i_{1}}, \ldots, t_{i_{n}}\right)$. Create $n!+1$ sets, one $U_{\sigma}$ for each permutation $\sigma$ of the set $\{1,2, \ldots, n\}$ and $V$ : For each $t \in T^{(n)}, \hat{t}=\left(t_{i_{1}}, \ldots, t_{i_{n}}\right)$ put $t \in U_{\sigma}$ if

$$
\left(g^{t_{\left.i_{0(1)}\right)}^{\alpha_{1}}} \ldots\left(g^{t_{\left.i_{o(n)}\right)}}\right)^{\alpha_{n}}=1,\right.
$$

and put $t \in V$ if $t \notin U_{\sigma}$, for any $\sigma$.
By Ramsey's Theorem, there exists an infinite subset $T_{0} \subseteq T$, such that $T_{0}^{(n)} \subseteq U_{\sigma}$, for some $\sigma$, or $T_{0}^{(n)} \subseteq V$. Suppose, for a contradiction, that $T_{0}^{(n)} \subseteq V$, then the set $\left\{g^{x} \mid x \in T_{0}\right\}$, is infinite. By the property $\mathcal{V}(\infty)$, there exist $n$ distinct elements $t_{1}, \ldots, t_{n} \in T_{0}$, such that $\left(g^{t_{1}}\right)^{\alpha_{1}} \ldots\left(g^{t_{n}}\right)^{\alpha_{n}}=1$, but then $t=\left\{t_{1}, \ldots, t_{n}\right\}$ lies in some $U_{\sigma}$, a contradiction.

Thus $T_{0}^{(n)} \subseteq U_{\sigma}$, for some $\sigma$. Moreover, by restricting the order $\leqslant$ to $T_{0}$ we may assume that $T_{0}=\left\{t_{1}, t_{2}, \ldots\right\}$ and $t_{i}<t_{j}$ if $i<j$. Hence for any $i_{1}<i_{2}<\ldots<i_{n}$, we have

$$
\left(g^{t_{i_{\sigma(1)}}}\right)^{\alpha_{1}} \ldots\left(g^{t_{\left.i_{\sigma(n)}\right)}}\right)^{\alpha_{n}}=1 .
$$

Now consider a sequence

$$
i_{1}<i_{2} \ldots<i_{n-1}<i_{n}<i_{n+1}<i_{n+2}<i_{n+3}<\ldots<i_{2 n+1}
$$

of $2 n+1$ indices and suppose that $k \in\{1,2, \ldots, n\}$ is fixed and let $\sigma(s)=k$. Define a sequence $j_{1}<\ldots<j_{n}$ as follows: the first $k-1$ elements are $j_{1}=i_{1}, \ldots, j_{k-1}=i_{k-1}$ (if $k=1$ this is empty), $j_{k}=i_{n+1}$, and the last $n-k$ elements are $j_{k+1}=i_{n+3}, \ldots, j_{n}=i_{2 n-k+2}$ (if $k=n$ this is empty). Thus

$$
\left(g^{t_{i_{n+1}}}\right)^{\alpha_{s}}=\left(\left(g^{t_{\text {lo(1) }}}\right)^{\alpha_{1}} \ldots\left(g^{t_{l o(s-1)}}\right)^{\alpha_{s-1}}\right)^{-1}\left(\left(g^{t_{l(s+1)}}\right)^{\alpha_{s+1}} \ldots\left(g^{t_{l o(n)}}\right)^{\alpha_{n}}\right)^{-1} .
$$

Now if we put $j_{k}=i_{n+2}$ in the above sequence, we have

$$
\left(g^{t_{l_{n}+2}}\right)^{\alpha_{s}}=\left(\left(g^{t_{\left.i_{\sigma(1)}\right)}}\right)^{\alpha_{1}} \ldots\left(g^{\left.t_{i_{\sigma(s-1}}\right)}\right)^{\alpha_{s-1}}\right)^{-1}\left(\left(g^{\left.\left.t_{\left.i_{\sigma(s+1)}\right)}\right)^{\alpha_{s+1}} \ldots\left(g^{t_{i_{\sigma(n)}}}\right)^{\alpha_{n}}\right)^{-1}, ~, ~, ~}\right.\right.
$$

and thus $\left(g^{t_{n+1}}\right)^{\alpha_{s}}=\left(g^{t_{n+2}}\right)^{\alpha_{s}}$. Therefore $t_{i_{n+1}} t_{i_{n+2}}^{-1} \in C_{H}\left(g^{\alpha_{s}}\right)$. Now if $k$ runs through the set $\{1,2, \ldots, n\}$, so does $s$. Thus

$$
t_{i_{n+1}} t_{i_{n+2}}^{-1} \in \bigcap_{s=1}^{n} C_{H}\left(g^{\alpha_{s}}\right)=C_{H}\left(g^{d}\right),
$$

a contradiction.
It is natural to ask whether every infinite $\mathcal{V}(\infty)$-group belongs to $\mathcal{V}$.
The answer, in general, is negative. In fact, there is an infinite group satisfying the condition $\mathcal{V}(k)$ for some positive integer $k$ which does not belong to $\geqslant$.

For example, we can take a group $K$ (with $m=2$ and $n$ to be a sufficiently large prime, $n>10^{10}$ ) in Theorem 31.5 in [8]. This group $K$ is given by all relations of the form $A^{n^{2}}=1$ and $A^{n}=B^{n}$, where $A$ and $B$ run through a special set of words. The group $K$ is 2 -generated and of exponent $n^{2}$, and it is a central extension of $B(2, n)$ (this is the 2 -generated free Burnside group of exponent $n$ ) by a cyclic central subgroup $\langle z\rangle$ of order $n$.

Thus $K$ is infinite, since $B(2, n)$ is infinite, and $K^{n}=\langle z\rangle$ is a finite (central) cyclic subgroup of $K$. Now we show that the set $X$ of all elements of order $n$ in $K$ coincides with $\langle z\rangle$ and thus is finite. For this purpose we need to show that all non-central elements of $K$ have order $n^{2}$. Take an element $x$ outside $Z(K)=\langle z\rangle$. It follows from the construction of $K$ that $x$ is conjugate in $K$ to a product $A^{k} z^{t}$, where $A^{n}=z$. Then $\left(A^{k} z^{t}\right)^{n}=\left(A^{n}\right)^{k}\left(z^{n}\right)^{t}=z^{k} \neq 1$, since $k$ is not divided by $n$. Thus $x$ is of order $n^{2}$ as required.

Let, now $\mathcal{O}$ be the variety defined by the law $x_{1}^{n} \ldots x_{n}^{n}=1$. Then $K \in \mathcal{O}\left(n^{2}\right)$. For, let $x_{1}, \ldots, x_{n^{2}}$ be distinct elements of $K$. Thus $x_{1}^{n}, \ldots, x_{n}^{n_{2}}$
are in $K^{n}$ and so there exists $\left\{y_{1}, \ldots, y_{n}\right\} \subset\left\{x_{1}, \ldots, x_{n^{2}}\right\}$ such that $y_{1}^{n}=$ $=\ldots=y_{n}^{n}=c \in Z(K)=\langle z\rangle$. Therefore $y_{1}^{n} \ldots y_{n}^{n}=c^{n}=1$, since $|K|=$ $=|Z(K)|=n$.

Corollary 4. Let $G \in \mathfrak{V}^{\#}$ be an infinite group, then $G^{d}=\left\langle g^{d} \mid g \in G\right\rangle$ is finite.

Proof. By Lemma 3, $\left|G: C_{G}\left(g^{d}\right)\right|$ is finite, for all $g \in G$. Thus $G^{d} \leqslant$ $\leqslant F$, the FC-center of $G$. If $F$ is infinite then $F \in \mathfrak{V}$, by Lemma 1 , and so $G \in \mathcal{O}=\mathscr{B}_{d} \cup \mathscr{F}$ by Lemma 2, and thus $G^{d}=1$. If $F$ is finite, then $G^{d}$ is also finite, as required.

Proof of the Theorem. Let $G$ be an infinite group in $\mathcal{V}^{\#}$ and assume $G \notin \mathfrak{V}$. Then $G^{d}$ is finite, by Corollary 4. Write $H:=C_{G}\left(G^{d}\right)$. Then $G / H$ is finite and $a^{d} \in Z(H)$, for any $a \in H$. We show that $H / F C(H)$ has exponent 2 where $F C(H)$ is the FC-centre of $H$. Let $a \in H, a^{2} \notin F C(H)$. Then the set $X=\left\{a^{g} \mid g \in H\right\}$ is infinite. Let $X_{1}=X_{2}=\ldots=X_{n}=X$. Then, since $G \in \mathfrak{V}^{\#}$, there exist $g_{1}, \ldots, g_{n} \in H$ such that

$$
\left(a^{g_{1}}\right)^{\alpha_{1}}\left(a^{g_{2}}\right)^{\alpha_{2}} \ldots\left(a^{g_{n}}\right)^{\alpha_{n}}=1=a^{\alpha_{1}} a^{\alpha_{2}} \ldots a^{\alpha_{n}}
$$

since $a^{d} \in Z(H)$. Write $\alpha_{i}=d \beta_{i}$ for all $i \in\{1, \ldots, n\}$. Then

$$
\begin{equation*}
\left(a^{d}\right)^{\beta_{1}+\beta_{2}+\ldots+\beta_{n}}=1 . \tag{*}
\end{equation*}
$$

Now let $Y=\left\{\left(a^{2}\right)^{g} \mid g \in H\right\}$, then $Y$ is infinite, since $a^{2} \notin F C(H)$. For $X_{1}=Y, X_{2}=X_{3}=\ldots=X_{n}=X$, there exist $h_{1}, \ldots, h_{n} \in H$ such that $\left(a^{2 h_{1}}\right)^{\alpha_{1}}\left(a^{h_{2}}\right)^{\alpha_{2}} \ldots\left(a^{h_{n}}\right)^{\alpha_{n}}=1$. Then $a^{2 \alpha_{1}+\alpha_{2}+\ldots+a_{n}}=1$ and

$$
\begin{equation*}
\left(a^{d}\right)^{2 \beta_{1}+\beta_{2}+\ldots+\beta_{n}}=1 . \tag{**}
\end{equation*}
$$

From (*) and (**), we get $\left(a^{d}\right)^{\beta_{1}}=1$, and arguing similarly with $X=$ $=X_{1}=\ldots=X_{i-1}=X_{i+1}=\ldots=X_{n}$ and $X_{i}=Y$, we obtain $\left(a^{d}\right)^{\beta_{\imath}}=1$ for any $i$ in the set $\{1, \ldots, n\}$. Then $a^{d}=1$, since $\operatorname{gcd}\left(\beta_{1}, \beta_{2}, \ldots, \beta_{n}\right)=1$. But from $a^{d}=1$, we have $\left(a^{g}\right)^{d}=1$, for any $g$ in $H$ and, by Lemma 2, the set $\left\{a^{g} \mid g \in H\right\}$ is finite, that is $a \in F C(H)$, a contradiction.

Therefore $H / F C(H)$ is a locally finite group, $F C(H)$ is finite by Lemmas 1 and 2, and so $H$ is locally finite. Then $H$ can not be infinite by Lemma 2. Thus $H$ is finite which forces $G$ to be finite. This is a contradiction, which completes the proof.
